Their mission is to assist in the development of a residential community to be built in Acadiana for individuals with special needs. She assists other non-profit organizations with their fundraising efforts building unity in the special needs community and prides herself as being an advocate for autism.

In October 2015, she was awarded "Volunteer of the Year" from Lafayette City/Parish Disability Awareness Committee.

Karen is currently the President of St Mary's Family & Friends (SMFF) Parents Group for St Mary's Residential Training School. She is married to Wendell Juneau with 3 children and their oldest son has autism.

Wendell J. Juneau, PT

Wendell Juneau is from Cottonport Louisiana. He is a graduate from LSU and received his Physical Therapy degree from LSU Medical School of Allied Health in Shreveport Louisiana. After moving to Lafayette, he & his wife, Karen, founded Rosewood Rehabilitation Outpatient Therapy in 2000. He is a founder & Managing Board Member of Cirra Group, Juneau Land Co, Freeland Properties & BJD Properties.

Wendell married Karen in 1992 and they have three children, Skyler, JP and Elise. Skyler currently lives at St. Mary's Residential Training School in Alexandria, LA. They realized early-on that Skyler had autism, and never made his disabilities an excuse, but instead a reason to accomplish so much.

Lyle created a sustainable plan for the organization, which launched in 1989 and grew to enjoy a national reputation for excellence and innovation in the performing arts field. PASA programming encompassed a range of outreach and residency activities that engaged audience members and philanthropists; set the community standard for prospecting, recruiting and sustaining corporate support, and implanted unique projects that impacted educational institutions in level-appropriate activities, including projects that served many academic areas at the University of Louisiana Lafayette. She is an experienced grant writer, with a 90% success rate.

Her most recent work has been with the Birmingham Music Club, a performing arts presenter which needed strategies to stabilize, refocus and reconnect the organization to donors, audiences, the news media and other constituents. She plays an ongoing role as an advisor to the Elisa Monte Dance Company.

Her network of influence stretches across existing and potential philanthropists within Lafayette's minority communities, the news media, government agencies and national performing arts circles.
